WHEREAS, the governing body of the City of Westwood Hills, Kansas deems it appropriate that the City have an ordinance comparable to the statutes of the state of Kansas requiring the owner of a motor vehicle to provide motor vehicle liability insurance and requiring the operator of a motor vehicle to display, upon demand, evidence of financial security to a law enforcement officer.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WESTWOOD HILLS, KANSAS:

Section 1. The Westwood Hills Municipal Code, Section 11-104 is hereby added and shall read as follows:

11-104. The provisions of K.S.A. 40-3104, as amended, are hereby incorporated by reference as if fully set forth herein.

Section 2. The Westwood Hills Municipal Code, Section 11-105 is hereby added and shall read as follows:

11-105. The provisions of K.S.A. 40-3105, as amended, are hereby incorporated by reference as if fully set forth herein.

Section 3. The Westwood Hills Municipal Code, Section 11-106 is hereby added and shall read as follows:

11-106. The provisions of K.S.A. 40-3106, as amended, are hereby incorporated by reference as if fully set forth herein.

Section 4. This ordinance shall take effect upon its passage and publication once in the official city newspaper.

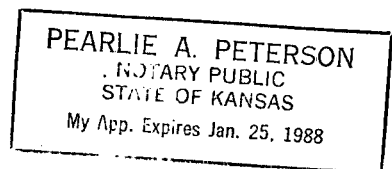
