11-104. The provisions of K.S.A. 40-3104, as amended, are hereby incorporated by reference as if fully set forth herein.

Section 2. The Westwood Hills Municipal Code, Section 11-105 is hereby added and shall read as follows:

11-105. The provisions of K.S.A. 40-3105, as amended, are hereby incorporated by reference as if fully set forth herein.

Section 3. The Westwood Hills Municipal Code, Section 11-106 is hereby added and shall read as follows:

11-106. The provisions of K.S.A. 40-3106, as amended, are hereby incorporated by reference as if fully set forth herein.
