## WESTWOOD HILLS, KANSAS ORDINANCE NO. 142

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WESTWOOD HILLS, KANSAS, as follows:

Section 1. Section 7-112A. of the Municipal Code of the City of Westwood Hills, Kansas, 1979 Edition, is hereby added to read as follows:

Section 7-112A - Certain Animals: Keeping Prohibited. It shall be unlawful to keep, harbor, own or in any way possess within the corporate limits of the City of Westwood Hills, Kansas:

- (1) Any warm-blooded, carnivorous or omnivorous, wild or exotic animal (including but not limited to non-human primates, raccoons, skunks, foxes and wild and exotic cats; but excluding ferrets and small rodents of varieties used for laboratory purposes).
  - (2) Any animal having poisonous bites.
- (3) Any pit bull dog. For purposes of this Section, "pit bull dog" is defined to mean:
  - (a) The bull terrier breed of dog;
  - (b) Staffordshire bull terrier breed of dog;
  - (c) The American pit bull terrier breed of dog;
  - (d) The American Staffordshire terrier breed of dog;
  - (e) Dogs of mixed breed or of other breeds than above listed which breed or mixed breed is known as pit bulls, pit bull dogs, or pit bull terriers;
  - (f) Any dog which has the appearance and characteristics of being predominantly of the breeds of bull terrier, Staffordshire bull terrier, American pit bull terrier, American Staffordshire terrier; any other breed commonly known as pit bulls, pit bull dogs, or pit bull terriers; or a combination of any of these breeds.

(4) Any cattle, hogs, horses, mules, sheep, goats, chickens, ducks, geese or pigeons.

Subsection (3) hereof shall not include any pit bull dog kept, harbored, owned or in any way possessed within the corporate limits of the City of Westwood Hills, Kansas prior to October 5, 1987, but shall apply to any pit bull dog brought into the City subsequent to that date.

Section 2. This Ordinance shall take effect upon its publication in the official city newspaper.

  - (f) Any dog which has the appearance and characteristics of being predominantly of the breeds of bull terrier, Staffordshire bull terrier, American pit bull terrier, American Staffordshire terrier; any other breed commonly known as pit bulls, pit bull dogs, or pit bull terriers; or a combination of any of these breeds.

(4) Any cattle, hogs, horses, mules, sheep, goats, chickens, ducks, geese or pigeons.

Subsection (3) hereof shall not include any pit bull dog kept, harbored, owned or in any way possessed within the corporate limits of the City of Westwood Hills, Kansas prior to October 5, 1987, but shall apply to any pit bull dog brought into the City subsequent to that date.

Section 2. This Ordinance shall take effect upon its publication in the official city newspaper.
