

CITY OF WESTWOOD HILLS, KANSAS  
ORDINANCE NO. 145

AN ORDINANCE CHANGING THE ANNUAL SEWAGE SERVICE CHARGE

WHEREAS, pursuant to Kansas statutes, the City of Westwood Hills is authorized to establish just, reasonable and equitable service charges to be paid to the City for the use of its sewer system; and

WHEREAS, the City has in the past collected such sewage service charges and credited such charges to a separate fund known as the sewage disposal fund and used such fund exclusively for the operation and maintenance of its sewer system; and

WHEREAS, due to a balance existing in the sewage disposal fund and the City sewer system becoming a part of Westport Annex Sewer District No. 1, the City can lower its annual sewage service charge from \$108.00 per year per sewer connection to \$48.00 per year and meet its obligations.

THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WESTWOOD HILLS, as follows:


Section 1. The annual sewage service charge previously established at \$108.00 a year per sewer connection is changed to \$48.00 per year per sewer connection.

Section 2. The City Clerk shall certify the charge of \$48.00 per year per sewer connection as a sewer service charge to the County Clerk by August 25, 1988, to be levied as a tax as otherwise provided by law.

Section 3. This ordinance repeals all prior ordinances establishing the rate for sewer service charges.

Section 4. This ordinance shall be effective upon its publication once in the official City newspaper.

PASSED by the Governing Body and APPROVED by the Mayor this 1st day of August, 1988.

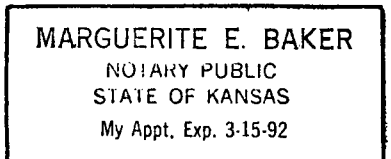
