Section 1. Section 5-102 of the Municipal Code of West-wood Hills. Kansas, is hereby amended to read as follows:
5-102. Uniform Building Code, Incorporation by Reference.
There is hereby incorporated by reference, pursuant to K.S.A. 12-3009 and 12-3015 for the purpose of regulating the design, construction, alteration, enlargement, equipment repair, demolition, removal, conversion, use of, maintenance, reroofing, for all buildings and structures, and regulating the issuance of permits, collection of fees, the making of inspections, and providing penalties for violations thereof, that certain standard building code known as the Uniform Building Code, 1985 Edition, published by the International Conference of Building Officials, including the generic fire-resistive assembles listed in the Fire Resistance Design Manual, 1981 Edition, published by the Gypsum Association as referred to in tables nos. 43-A, 43-B, and 43-C and Appendix Chapters 35 of the specified Uniform Building Code, including the generation of the City of Westwood Hills, Kansas' with all sections or portions thereof intended to be omitted, added or changed clearly marked to show any such omissions, additions or changes, and shall be filed with the City Clerk, be open to inspection and available to the public at all reasonable hours, except that such of ficial copy shall not be removed from the office of the City Clerk, be open to inspection and available to the public at all reasonable hours, except that such of ficial copy shall not be removed from the office of the City Clerk.
