## WESTWOOD HILLS, KANSAS ORDINANCE NO. |6|

An ordinance levying assessments on lots, pieces and parcels of land in the City of Westwood Hills, Kansas, for the purpose of paying all of the costs for improvements consisting of the removal and replacement of curb, gutter and driveway approaches on 50th Terrace between Rainbow Boulevard and State Line Road and further providing for the payment of said assessments and for the certification of unpaid assessments to the County Clerk of Johnson County, Kansas.

BE IT ORDAINED by the Governing Body of the City of Westwood Hills, Kansas:

Section 1. Special assessments to pay the cost of the removal and replacement of curb, gutter and driveway approaches on 50th Terrace between Rainbow Boulevard and State Line Road are hereby levied against the several lots, pieces and parcels of land liable for special assessments for said improvement as follows:

Total Assessments to Improvement District

Section 2. Such assessments, with accrued interest, are levied concurrent with general taxes and shall be payable in ten (10) equal amount installments. The first installment shall be payable at the time of the first payment of general property taxes.

Section 3. All assessments shall bear interest at a rate not to exceed the statutory permissible interest per annum, provided any assessment paid in full within 30 days from the date of the passage of this ordinance shall not bear interest.

Section 4. The owner of a property so assessed may, at any time prior to 90 days from the date of the passage hereof, pay the whole of this assessment against any lot or parcel of land, together with any accrued interest thereon, by making such payment to the office of the City Clerk.

Section 5. Assessments not paid prior to the date provided in Section 4. herein shall be certified, together with the interest accrued, or to accrue, by the City Clerk to the County Clerk of Johnson County, Kansas, and collected in the manner as other taxes.

Section 6. This Ordinance shall take effect and be in force from and after its publication as provided by law.
