AN ORDINANCE AUTHORIZING THE ISSUANCE OF \$25,862.85 GENERAL OBLIGATION BONDS, SERIES 1993 OF THE CITY OF WESTWOOD HILLS, KANSAS, UNDER THE AUTHORITY OF K.S.A. 10-101 TO 10-132, INCLUSIVE, K.S.A. 10-620 to 10-632, INCLUSIVE, AND K.S. A. 12-6a01, et. seq., ALL AS AMENDED

WHEREAS, The Governing Body of the City of Westwood Hills, Kansas, (the "City") has caused certain curb and gutter street improvements (the "Improvements") to be made in the City under the authority of K.S.A. 12-6a-01 et seq.; and

WHEREAS, all legal requirements pertaining to the Improvements have been complied with and the total cost of making the Improvements has been ascertained to be \$40,490 (the "Project Cost"); and

WHEREAS, \$40,490 of the Project Cost has been assessed by the City against those lots and parcels of land specially benefitted thereby, \$14,627.15 of which was paid to the City by the owners of such property; and

WHEREAS, the Project Cost was paid by the City by the expenditure of unencumbered funds of the City to be reimbursed with the proceeds of the Bonds authorized and after crediting the amount paid by the owners of the property assessed by the City there is unpaid the balance of the Project Cost in the amount of \$25,862.85 for which general obligation bonds of the City may be issued; and

WHEREAS, the City deems it necessary and advisable to issue its general obligation bonds in the aggregate principal amount of Twenty-five Thousand Eight Hundred Sixtytwo and 85/100 Dollars (\$25,862.85) for the purpose of paying the balance of the Project Cost; and

WHEREAS, the City can sell such general obligation bonds without publishing a notice of sale of its intent to sell such bonds and such sale may be made by private sale;

and WHEREAS, the City has negotiated a private sale of such bonds and does hereby authorize the issuance and sale of the Bonds to the purchaser of such bonds through the private sale thereof.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WESTWOOD HILLS, JOHNSON COUNTY, KANSAS:

Section 1. That for the purpose of providing funds to pay the cost of making the Improvements hereinbefore described, there shall be, and hereby are, issued General Obligation Bonds, Series 1993 of the City in the aggregate principal amount of Twentyfive Thousand Eight Hundred Sixty-two and 85/100 Dollars (\$25,862.85) (the "Bond") as provided by K.S.A. 10-101 to 10-132, inclusive, K.S.A. 10-620 to 632, inclusive, and K.S.A. 12-6a01 et. seq., all as amended.

Section 2. The terms and provisions of the Bond shall be as determined by law and a resolution passed and approved by the governing body of the City.

Section 3. The governing body of the City, the Mayor and the City Clerk are authorized and empowered to execute and attest such other documents as may be required for the issuance and delivery of the Bond.

Section 4. This Ordinance shall take effect and be in force from and after its passage and publication in the official City newspaper.
