AN ORDINANCE AUTHORIZING AND PROVIDING FOR THE RE-CODIFICATION OF THE MUNICIPAL CODE OF WESTWOOD HILLS, KANSAS 1979 EDITION AND THE GENERAL ORDINANCES OF THE CITY OF WESTWOOD HILLS, KANSAS, AND THE PUBLICATION OF SUCH RE-CODIFICATION IN PERMANENTLY BOUND OR LOOSE-LEAF BOOK FORM.

Be it Ordained by the Governing Body of the City of Westwood Hills:

Section 1. That a re-codification of The Municipal Code of Westwood Hills, Kansas, 1979 Edition, as authorized by K.S.A. 12-3014 and K.S.A. 12-3015, is hereby ordered, authorized and provided for. When completed, the re-codification shall be adopted by ordinance and published together with the adopting ordinance in permanently bound or loose-leaf book form and not less than twelve (12) copies shall be published. Such codification shall be entitled, "The Municipal Code of Westwood Hills, Kansas, 1994 Edition". The said code shall be duly certified by the City Clerk. One copy of the code shall be filed in the office of the City Clerk and shall constitute an ordinance book.

Section 2. That this ordinance shall take effect and be in force from and after its publication once in the official city newspaper.
