CITY OF WESTWOOD HILLS, KANSAS ORDINANCE NO. 172

AN ORDINANCE AMENDING CHAPTER 5 OF THE WESTWOOD HILLS MUNICIPAL CODE BY AMENDING SECTION 5-101 TO INCORPORATE BY REFERENCE THE LATER EDITIONS OF VARIOUS BUILDING CODES.

WHEREAS, the Governing Body of Westwood Hills, Kansas has determined that it is advisable to amend Section 101 of Chapter 5 of the Municipal Code of the City to adopt more recent editions of various uniform codes relating to building and construction.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WESTWOOD HILLS, KANSAS, as follows:

Section 1. Section 101 of Chapter 5 of the Code of the City of Westwood Hills is hereby amended to read as follows:

"5-101. BUILDING CODES ADOPTED BY REFERENCE. Those certain stated codes known as the:

1994 Uniform Building Code,

1994 Uniform Mechanical Code,

1995 International Plumbing Code,

1993 National Electric Code with Uniform Administration Code Provisions,

1994 Uniform Fire Code,

1994 Uniform Code for the Abatement of Dangerous Buildings,

1994 Uniform Housing Code,

1995 CABO One and Two Family Dwelling Code,

are hereby established as the Building Code, Mechanical Code, Plumbing Code, Electrical Code, Fire Code, Dangerous Buildings Code, Housing Code, and One & Two Family Dwelling Code of and for the city and the above-described codes and their supplements are hereby incorporated herein by reference and made part of this code, save and except such portions that are deleted or amended by ordinance.

Section 2. This Ordinance shall be effective upon its passage, approval by the Mayor and publication once in the official city newspaper.
