ORDINANCE NO. 197

AN ORDINANCE REGULATING BUILDING AND CONSTRUCTION PRACTICES AND REGULATING AND CONTROLLING THE DESIGN, CONSTRUCTION, QUALITY OF MATERIAL, ERECTION, INSTALLATION, ALTERATION, REPAIR, LOCATION, RELOCATION, REPLACEMENT, ADDITION TO, USE OR MAINTENANCE OF PROPERTY, BUILDINGS, AND STRUCTURES AND TO PROVIDE FOR SUPPLIED UTILITIES AND FACILITIES AND OTHER PHYSICAL THINGS AND CONDITIONS ESSENTIAL TO ENSURE THAT STRUCTURES ARE SAFE, SANITARY, AND FIT FOR OCCUPATION AND USE WITHIN THE CORPORATE LIMITS OF THE CITY OF WESTWOOD HILLS, KANSAS; INCORPORATING BY REFERENCE THE 2000 EDITION OF THE INTERNATIONAL BUILDING CODE, EXCLUDING ALL APPENDICES; THE 2000 EDITION OF THE RESIDENTIAL CODE FOR ONE- AND TWO-FAMILY DWELLINGS INCLUDING APPENDIX CHAPTERS A., B., C., D., E., J., AND K., BUT EXCLUDING APPENDIX CHAPTERS F., G., H., AND I.; THE 2000 EDITION OF THE INTERNATIONAL MECHANICAL CODE INCLUDING APPENDIX CHAPTER A., BUT EXCLUDING APPENDIX CHAPTER B.; THE 2000 EDITION OF THE INTERNATIONAL FIRE CODE, EXCLUDING ALL APPENDIX CHAPTERS; THE 2000 EDITION OF THE INTERNATIONAL PLUMBING CODE EXCLUDING ALL APPENDIX CHAPTERS: THE 2000 EDITION OF THE INTERNATIONAL FUEL GAS CODE. INCLUDING APPENDIX CHAPTERS A., B., AND C., BUT EXCLUDING APPENDIX CHAPTER D.: AND THE 1999 EDITION OF THE NATIONAL ELECTRICAL CODE, INCLUDING APPENDIX CHAPTERS A., B., C. D., AND E.; WITH CERTAIN OMISSIONS, CHANGES AND ADDITIONS THERETO AND PRESCRIBING ADDITIONAL REGULATIONS; PROVIDING CERTAIN PENALTIES; SUBSTITUTING THE PROPERTY MAINTENANCE CODES OF THE CITY OF WESTWOOD HILLS FOR THE INTERNATIONAL PROPERTY MAINTENANCE CODE; ESTABLISHING A BOARD OF CODE APPEALS, AND THE MEMBERSHIP AND PROCEDURES THERETO: ESTABLISHING CERTAIN STORM WATER AND DRAINAGE CONTROL PROCEDURES; PROVIDING FOR CERTAIN FEES; ESTABLISHING THE APPLICABILITY OF THE NATIONAL ELECTRICAL CODE; AND REPEALING CERTAIN SECTIONS OF THE MUNICIPAL CODE.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WESTWOOD HILLS, KANSAS:

Section 1. INCORPORATING THE 2000 EDITION OF THE INTERNATIONAL BUILDING CODE. There is hereby incorporated by reference for the purpose of regulating building and construction practices and to provide for the public safety and welfare within the corporate limits of the City of Westwood Hills, Kansas, that certain document known as the "International Building Code" 2000 Edition, excluding all Appendices, as published by the International Code

Council, Inc., save and except such articles, sections, parts or portions as are hereafter omitted, deleted, modified or changed. No fewer than three copies of the International Building Code shall be marked or stamped "Official Copy as Adopted by Ordinance No. 197," with all sections or portions thereof intended to be omitted or changed clearly marked to show any such omission or change and to which shall be attached a copy of this ordinance, and filed with the city clerk to be open to inspection and available to the public at all reasonable hours. One such copy, however, may be on a CD-ROM or in another electronic form, provided that any changes or amendments are attached to or recorded in such electronic format so as to be readily understood. The police department, municipal judge and all administrative departments of the city charged with enforcement of the ordinance shall be supplied, at the cost of the city, such number of official copies of such International Building Code similarly marked, as may be deemed expedient.

Section 2. REVISED, AMENDED, OR DELETED SECTIONS OF THE 2000 EDITION OF THE INTERNATIONAL BUILDING CODE: The following sections of the International Building Code shall be revised, amended, or deleted:

- 1. Section 101.1 shall be amended to read "These regulations shall be known as the Building Code of the City of Westwood Hills, Kansas."
- 2. Section 101.2 shall be amended to read: "Exception: Detached one- and two-family dwellings and multiple single-family dwellings (townhouses) not more than three stories high with separate means of egress and their accessory structures shall comply with the International Residential Code as amended."
- 3. Section 101.4.1. shall be amended to read: "The provisions of the National Electrical Code shall apply to the installation of electrical systems, including alterations, repairs, replacement, equipment, appliances, fixtures, fittings and appurtenances thereto."
- 4. Section 105.2. entitled "Work exempt from permit," shall be revised to and amended to delete the exemptions numbered 1. through 13. under the sub-category "Building" from the permit requirement. The requirement for a permit is further set forth in section 5-103 of the Westwood Hills Municipal Code.
- 5. Section 105.3.2 shall be amended to read as follows: "An application for a permit for any proposed work shall be deemed to have been abandoned 180 days after the date of filing, unless such application has been pursued in good faith or a permit has been issued; except that the building official is authorized to grant one or more extensions of time for additional periods not exceeding 180 days each. The extension or extensions shall be requested in writing and justifiable cause demonstrated."
- 6. Section 108.3, entitled "Building permit valuations," shall be amended to add the following sentence at the end of said provision: "Alternatively, building permits fees

may be set and established administratively by the City according to the schedule as established by the City and as amended."

7. Section 113.4, entitled "Violation penalties," shall be amended to add the following at the end of said provision:

In addition to any administrative remedies or other legal or equitable remedies provided, any persons violating the provisions of this code shall, upon conviction thereof, be fined in a sum not to exceed \$500, or be imprisoned not to exceed six months or be both so fined and imprisoned. Each person shall be guilty of a separate offense for each and every day during any portion of which any violation of any provision of the city ordinances is committed, continued or permitted by any such person.

- 8. Section 1612.3, entitled "Establishment of flood hazard area," shall be deleted, and in lieu thereof, shall be inserted the following: "To establish flood hazard areas, the City of Westwood Hills may adopt a flood hazard map and supporting data. If and when the city undertakes such a task, such shall comply with the requirements of Section 1612.3 and shall be incorporated into the city's code requirements."
- 9. Section 3409.2, entitled "Applicability," shall be amended so that the first sentence thereof shall read: "Structures existing prior to the date of adoption of this code, in which there is work involving additions, alterations or changes of occupancy shall be made to conform to the requirements of this section or the provisions of Sections 3402 through 3406."

Section 3. INCORPORATING THE 2000 EDITION OF THE INTERNATIONAL RESIDENTIAL CODE FOR ONE-AND TWO-FAMILY DWELLINGS. There is hereby incorporated by reference for the purpose of regulating building and construction practices and to provide for the public safety and welfare within the corporate limits of the City of Westwood Hills, Kansas, that certain document known as the "International Residential Code for One-and Two-Family Dwellings" 2000 Edition, excluding Appendix Chapters F., G., H., and I. but including Appendix Chapters A., B., C., D., E., J., and K. as published by the International Code Council, Inc., save and except such articles, sections, parts or portions as are hereafter omitted, deleted, modified or changed. No fewer than three copies of the International Residential Code for One- and Two Family Dwellings shall be marked or stamped "Official Copy as Adopted by Ordinance No.197," with all sections or portions thereof intended to be omitted or changed clearly marked to show any such omission or change and to which shall be attached a copy of this ordinance, and filed with the city clerk to be open to inspection and available to the public at all reasonable hours. One such copy, however, may be on a CD-ROM or in another electronic form, provided that any changes or amendments are attached to or recorded in such electronic format so as to be readily understood. The police department, municipal judge and all administrative departments of the city charged with enforcement of the ordinance shall be supplied, at the cost of the city, such number of

official copies of such International Residential Code for One- and Two-Family Dwellings similarly marked, as may be deemed expedient.

Section 4. REVISED, AMENDED, OR DELETED SECTIONS OF THE 2000 EDITION OF THE INTERNATIONAL RESIDENTIAL CODE FOR ONE-AND TWO-FAMILY DWELLINGS. The following sections of the International Residential Code for One- and Two-Family Dwellings 2000 Edition shall be revised, amended, or deleted:

- 1. Section R101.1, entitled "Title," shall be amended to read: "These provisions shall be known as the Residential Code for One- and Two-Family Dwellings of the City of Westwood Hills, Kansas, and shall be cited as such and will be referred to herein as 'this code."
- 2. Section R105.2, entitled "Work exempt from permit," shall be revised and amended to delete the exemptions numbered 1. through 9. under the sub-category "Building" from the permit requirement. The requirement for a permit is further set forth in section 5-103 of the Westwood Hills Municipal Code.
- 3. Section R305.1, entitled "Minimum height," shall be amended to amend only the first sentence thereof to read as follows: "Habitable rooms, hallways, corridors, bathrooms, toilet rooms, laundry rooms and basements shall have a ceiling height of not less than 6 feet 8 inches." Also, the subparagraph of Section R305.1, entitled "Exceptions 3.," shall be amended to read as follows: "Not more than 50% of the required floor area of a room or space Is permitted to have a sloped ceiling less than 6 feet, 8 inches in height with no portion of the required floor area less than 5 feet in height."
- 4. Section R201.3, entitled "Terms defined in other codes," shall be amended to read as follows: "Where terms are not defined in this code and are defined in the 1999 National Electrical Code, International Building Code, International Fire Code, the International Fuel Gas Code, or the International Mechanical Code, such terms shall have meanings ascribed to them as in those codes."
- 5. Section R108.1, entitled "Building permit valuations," shall be amended to add the following sentence at the end of said provision: "Alternatively, building permits fees maybe set and established administratively by the City according to the schedule as established by the City and as amended."
- 6. Section R113.4, entitled "Violation penalties," shall be amended to add the following at the end of said provision:

In addition to any administrative remedies or other legal or equitable remedies provided, any persons violating the provisions of this code shall, upon conviction thereof, be fined in a sum not to exceed \$500, or be imprisoned not to exceed six months or be both so fined and imprisoned. Each person shall be guilty of a

separate offense for each and every day during any portion of which any violation of any provision of the city ordinances is committed, continued or permitted by any such person.

7. Section 301.2, entitled "Climatic and geographic design criteria, shall be amended as follows: "The criteria herein shall be administratively established by the building official and inserted herein."

Section 5. INCORPORATING THE 2000 EDITION OF THE INTERNATIONAL MECHANICAL CODE. There is hereby incorporated by reference for the purpose of regulating building and construction practices and to provide for the public safety and welfare within the corporate limits of the City of Westwood Hills, Kansas, that certain document known as the "International Mechanical Code" 2000 Edition, including Appendix Chapter A., but excluding Appendix Chapter B., as published by the International Code Council, Inc., save and except such articles, sections, parts or portions as are hereafter omitted, deleted, modified or changed. No fewer than three copies of the International Mechanical Code shall be marked or stamped "Official Copy as Adopted by Ordinance No. 197" with all sections or portions thereof intended to be omitted or changed clearly marked to show any such omission or change and to which shall be attached a copy of this ordinance, and filed with the city clerk to be open to inspection and available to the public at all reasonable hours. One such copy, however, may be on a CD-ROM or in another electronic form, provided that any changes or amendments are attached to or recorded in such electronic format so as to be readily understood. The police department, municipal judge and all administrative departments of the city charged with enforcement of the ordinance shall be supplied, at the cost of the city, such number of official copies of such International Mechanical Code similarly marked, as may be deemed expedient.

Section 6. REVISED, AMENDED, OR DELETED SECTIONS OF THE 2000 EDITION OF THE INTERNATIONAL MECHANICAL CODE. The following sections of the International Mechanical Code 2000 Edition shall be revised, amended, or deleted:

- 1. Section 101.1, entitled "Title," shall be amended to read: "These regulations shall be known as the Mechanical Code of the City of Westwood Hills, Kansas, hereinafter referred to as 'this code."
- 2. Section 106.5.2, entitled "Fee schedule," shall be amended to read as follows: "The fees for mechanical work and the permits therefor shall be set and established administratively by the City according to the schedule as established by the City and as amended."
- 3. Section 106.5.3, entitled "Fee refunds," shall be amended to read as follows: "The building official is authorized to establish a refund policy."
 - 4. Section 201.3, entitled "Terms defined in other codes," shall be amended to

read as follows: "Where terms are not defined in this code and are used in the International Building Code, the National Electrical Code, the International Fire Code, the International Fuel Gas Code, or the International Plumbing Code, such terms shall have meanings ascribed to them as in those codes."

5. Section 108.4, entitled "Violation penalties," shall be amended to read as follows:

Persons who shall violate a provision of this code or shall fail to comply with any of the requirements thereof or who shall erect, install, alter, or repair mechanical work in violation of the approved construction documents or directive of the code official, or of a permit or certificate issued under the provisions of this code shall be guilty of a violation of this code. In addition to any administrative remedies or other legal or equitable remedies provided, any persons violating the provisions of this code shall, upon conviction thereof, be fined in a sum not to exceed \$500, or be imprisoned not to exceed six months or be both so fined and imprisoned. Each person shall be guilty of a separate offense for each and every day during any portion of which any violation of any provision of the city ordinances is committed, continued or permitted by any such person.

6. Section 108.5, entitled "Stop work orders," shall be amended so that the final sentence thereof shall read: "Any person who shall continue any work in or about the structure after having been served with a stop work order, except such work as that person is directed to perform to remove a violation or unsafe condition, shall be guilty of a violation of this code, and punished in accordance herewith."

Section 7. INCORPORATING THE 2000 EDITION OF THE INTERNATIONAL FIRE CODE. There is hereby incorporated by reference for the purpose of regulating building and construction practices and to provide for the public safety and welfare within the corporate limits of the City of Westwood Hills, Kansas, that certain document known as the "International Fire Code" 2000 Edition, excluding all Appendix Chapters, as published by the International Code Council, Inc., save and except such articles. sections, parts or portions as are hereafter omitted, deleted, modified or changed. No fewer than three copies of the International Fire Code shall be marked or stamped "Official Copy as Adopted by Ordinance No. 197," with all sections or portions thereof intended to be omitted or changed clearly marked to show any such omission or change and to which shall be attached a copy of this ordinance, and filed with the city clerk to be open to inspection and available to the public at all reasonable hours. One such copy, however, may be on a CD-ROM or in another electronic form, provided that any changes or amendments are attached to or recorded in such electronic format so as to be readily understood. The police department, municipal judge and all administrative departments of the city charged with enforcement of the ordinance shall be supplied, at the cost of the city, such number of official copies of such International Fire Code similarly marked, as may be deemed expedient.

Each person shall be guilty of a separate offense for each and every day during any portion of which any violation of any provision of the city ordinances is committed, continued or permitted by any such person.

- 5. Section 111.4, entitled "Failure to comply," shall be amended to read as follows: "Any person who shall continue any work after having been served with a stop work order, except such work as that person is directed to perform to remove a violation or unsafe condition, shall be guilty of a violation of this code, and punished in accordance herewith."
- 6. Section 3406.2.4.4., entitled "Locations where above-ground tanks are prohibited," shall be amended to read: "The storage of Class I and II liquids in above-ground tanks is prohibited anywhere in the city, except that a permit for such tanks may be granted by the Governing Body upon good cause shown and assurances by all competent sources that such tank poses no unreasonable threat or danger to persons or property."

No fewer than three copies of the International Plumbing Code shall be marked or stamped "Official Copy as Adopted by Ordinance No. 197," with all sections or portions thereof intended to be omitted or changed clearly marked to show any such omission or change and to which shall be attached a copy of this ordinance. and filed with the city clerk to be open to inspection and available to the public at all reasonable hours. One such copy, however, may be on a CD-ROM or in another electronic form, provided that any changes or amendments are attached to or recorded in such electronic format so as to be readily understood. The police department, municipal judge and all administrative departments of the city charged with enforcement of the ordinance shall be supplied, at the cost of the city, such number of official copies of such International Plumbing Code similarly marked, as may be deemed expedient.

Section 305.6. 1., entitled "Sewer depth," shall be amended to read as follows: Building sewers that connect to private sewage disposal systems shall be a minimum of 36 inches below finished grade at the point of septic tank connection. Building sewers shall be constructed in accordance with the requirements of Johnson County Wastewater.
 - 8. Section 904. 1, entitled "Roof extension," shall be amended to read as follows:

All open vent pipes that extend through a roof shall be terminated at least 18 inches above the roof, except that where a roof is to be used for any purpose other than weather protection, the vent extension shall be run at least 7 feet (2134 mm) above the roof.

No fewer than three copies of the International Fuel Gas Code shall be marked or stamped "Official Copy as Adopted by Ordinance No. 197," with all sections or portions thereof intended to be omitted or changed clearly marked to show any such omission or change and to which shall be attached a copy of this ordinance, and filed with the city clerk to be open to inspection and available to the public at all reasonable hours. One such copy, however, may be on a CD-ROM or in another electronic form, provided that any changes or amendments are attached to or recorded in such electronic format so as to be readily understood. The police department, municipal judge and all administrative departments of the city charged with enforcement of the ordinance shall be supplied, at the cost of

the city, such number of official copies of such International Fuel Gas Code similarly marked, as may be deemed expedient.

No fewer than three copies of the National Electrical Code shall be marked or stamped "Official Copy as Adopted by Ordinance No. 197," with all sections or portions thereof intended to be omitted or changed clearly marked to show any such omission or change and to which shall be attached a copy of this ordinance, and filed with the city clerk to be open to inspection and available to the public at all reasonable hours. Each person shall be guilty of a separate offense for each and every day during any portion of which any violation of any provision of the city ordinances is committed, continued or permitted by any such person.

Section 1612.3, entitled "Establishment of flood hazard area," shall be deleted, and in lieu thereof, shall be inserted the following: "To establish flood hazard areas, the City of Westwood Hills may adopt a flood hazard map and supporting data. One such copy, however, may be on a CD-ROM or in another electronic form, provided that any changes or amendments are attached to or recorded in such electronic format so as to be readily understood. Section 2. REVISED, AMENDED, OR DELETED SECTIONS OF THE 2000 EDITION OF THE INTERNATIONAL BUILDING CODE: The following sections of the International Building Code shall be revised, amended, or deleted:

- 1. Section 101.1 shall be amended to read "These regulations shall be known as the Building Code of the City of Westwood Hills, Kansas."
- 2. Section 101.2 shall be amended to read : "Exception: Detached one- and twofemily dwellings and multiple single-family dwallings (townhouses) not more than three stories high with separate means of egress and their accessory structures shall comply with the International Residential Code as amended."
- 3. Section 101.4.1, shall be amended to read: "The provisions of the National E ectrical Code shall apply to the installation of electrical systems, including alterations, repairs, replacement, equipment, appliances, fixtures, fittings and appurtenances thereto."
- 4. Section 105.2. entitled "Work exempt from permit," shall be revised to and amended to delete the exemptions numbered 1, through 13, under the sub-category "Euilding" from the permit requirement. The requirement for a permit is further set forth In section 5-103 of the Westwood Hills Municipal Code.
- 5. Section 105.3.2 shall be amended to read as follows: "An application for a permit for any proposed work shall be deemed to have been abandoned 180 days after the date of filing, unless such application has been pursued in good faith or a permit has been issued; except that the building official is authorized to grant one or more extensions of time for additional periods not exceeding 180 days each. The extension or extensions shall be requested in writing and justifiable cause demonstrated."
- 6. Section 108.3, entitled "Building permit valuations," shall be amended to add the following sentence at the end of said provision: "Afternatively, building permits fees
