## ORDINANCE NO. 23

AN ORDINANCE RELATING TO THE CALE, UNE AND DISPLAY OF FIRE WORKS.

## Be it ordained by the governing body of the City of Westwood Hills:

4-204 DEFINITION. Section 1. For the purposes of this chapter the term "fire works" shall be understood to mean any combustible or explosive composition or any substance or combination of substances or articles prepared for the purposes of producing a visible or audible effect for combustion, explosion, deflagration, or detonation.

4-205 REFAIL SALE. Section 2. Between June 27 and July 4 of each year, both inclusive, and at no other time, it shall be lawful to sell at retail fire works in the city; provided, however, that in the years the 4th of July falls on Sunday and the Succeeding Monday is officially observed, the use and sale of said fire works shall be permitted on July 5th.

4-206 PEACE OF SALE. Section 3. It shall be unlawful to sell fire works any place in the city except in a permanent building provided with a telephone, lights, water and at least one l-quart fire extinguisher.

4-207 THEOWING OR CLACING FIRE WORKS IN VEHICLES OR ASSEMBLIES. Section 4. It shall be unlawful for any person to throw or to place any fire works into or against any vehicle after igniting same or that may be exploded by contact, nor shall any fire works be thrown or placed in any gathering of persons so as to cause injury to any person or property.

TAKE EFFECT. Section 5. This ordinance shall take effect and be in force from and after its publication.
