ORDINANCE NO. 52

An Ordinance prohibiting parking at certain times and places.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WESTWOOD HILLS, KANSAS:

Section 1. That Article 1 of Chapter III, Revised Ordinances be and the same is hereby amended by adding thereto a new section reading as follows:

3-149 PARKING LIMITATIONS. No person shall park any vehicle on the east side of Rainbow north of the intersection of Rainbow with 48th Street Terrace between the hours of 2:00 A. M. and 9:00 A. M. or between the hours of 4:00 P. M. and 6:00 P. M.

Section 2. Any person violating Section 1 of this Ordinance shall be deemed guilty of a misdemeanor and shall be punished as provided in Section 3-301, Revised Ordinances, provided no person shall be convicted of such violation unless signs have been posted in the area affected stating the limitations on parking.

Section 3. This Ordinance shall take effect and be in force and effect from and after publication.
