ORDINANCE NO. 53

An Ordinance regulating left turns at intersections and prohibiting such turns at certain intersections and times.

Be it ordained by the governing body of the City of Westwood Hills, Kansas:

Section 1. That Section 3-118 of the Revised Ordinances of the City of Westwood Hills be and the same hereby is repealed and that there be enacted in lieu thereof a new section reading as follows:

3-118 VEHICLE TURNING LEFT.

The driver of a vehicle within an intersection intending to turn to the left shall yield the right of way to any vehicle approaching from the opposite direction which is within the intersection or so close thereto as to constitute an immediate hazard, but said driver, having so yielded and having given a signal when and as required by this article, may make such left turn and the drivers of all other vehicles approaching the intersection from said opposite direction shall yield the right of way to the vehicle making the left turn. It shall be unlawful for the driver of any vehicle to make a left turn between the hours of 4:00 p.m. and 6:00 p.m. at any of the following intersections:

Off of 48th Terrace and into Rainbow Boulevard;

Off of 49th Street and into Rainbow Boulevard;

Off of 49th Terrace and into Rainbow Boulevard;

Off of 50th Terrace and into Rainbow Boulevard.

or make a left turn between the hours of 7:00 a.m. and 9:00 a.m. at any of the following intersections:

Off of Rainbow Boulevard and into 48th Terrace;

Off of Rainbow Boulevard and into 49th Street;

Off of Rainbow Boulevard and into 49th Terrace;

Off of Rainbow Boulevard and into 50th Terrace;

provided that no person shall be convicted of making an unlawful left hand turn at any of the designated intersections until signs shall have been erected and maintained designating the prohibitions of this section.

Section 2. Any person violating Section 1 of this Ordinance shall be deemed guilty of a misdemeanor and upon conviction thereof shall be punished as provided in Section 3-301. Revised Ordinances of the City of Westwood Hills.

Section 3. This Ordinance shall take effect and be in force from and after its publication.

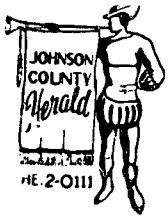

Be it ordained by the governing body of the City of Westwood Hills, Kansas:

Section 1. That Section 3-118 of the Revised Ordinances of the City of Westwood Hills be and the same hereby is repealed and that there be enacted in lieu thereof a new section reading as follows:

3-118 VEHICLE TURNING LEFT.

The driver of a vehicle within an intersection intending to turn to the left shall yield the right of way to any vehicle approaching from the opposite direction which is within the intersection or so close thereto as to constitute an immediate hazard, but said driver, having so yielded and having given a signal when and as required by this article, may make such left turn and the drivers of all other vehicles approaching the intersection from said opposite direction shall yield the right of way to the vehicle making the left turn. It shall be unlawful for the driver of any vehicle to make a left turn between the hours of 4:00 p.m. and 6:00 p.m. at any of the following intersections:

Off of 48th Terrace and into Rainbow Boulevard;

Off of 49th Street and into Rainbow Boulevard;

Off of 49th Terrace and into Rainbow Boulevard;

Off of 50th Terrace and into Rainbow Boulevard.

or make a left turn between the hours of 7:00 a.m. and 9:00 a.m. at any of the following intersections:

Off of Rainbow Boulevard and into 48th Terrace;

Off of Rainbow Boulevard and into 49th Street;

Off of Rainbow Boulevard and into 49th Terrace;

Off of Rainbow Boulevard and into 50th Terrace;

provided that no person shall be convicted of making an unlawful left hand turn at any of the designated intersections until signs shall have been erected and maintained designating the prohibitions of this section.

Section 2. Any person violating Section 1 of this Ordinance shall be deemed guilty of a misdemeanor and upon conviction thereof shall be punished as provided in Section 3-301, Revised Ordinances of the City of Westwood Hills.

or to make a left turn between the hours of 7:00 A. M. and 9:00 A. M. at any of the following intersections:

Off of Rainbow Boulevard and into 48th Terrace
Off of Rainbow Boulevard and into 49th Street
Off of Rainbow Boulevard and into 49th Terrace
Off of Rainbow Boulevard and into 50th Terrace

provided that no person shall be convicted of making an unlawful left hand turn at any of the designated intersections until signs shall have been erected and maintained designating the prohibitions of this section.
