in force from and after its publication.

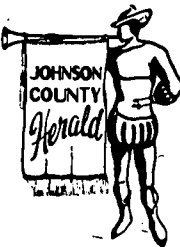

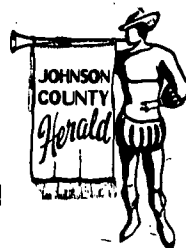
