ISSUANCE OF A TEMPORARY NOTE BY
THE CITY OF WESTWOOD HILLS, KAN-
SAS IN THE SUM OF \$12,387.42 TO PAY
PART OF THE COST OF CONSTRUCTING
CERTAIN SIDEWALK, CURB AND GUT-
TER REPLACEMENT IMPROVEMENTS
WITHIN THE CITY OF WESTWOOD HILLS,
KANSAS.

WHEREAS, the City of Westwood Hills,
Kansas by resolution published in the official
City newspaper on January 9, 1974 has
authorized the construction of certain side-
walk, curb and gutter repair and replace-
ment improvements throughout the City of
Westwood Hills, Kansas except in that part of
the City which has been officially designated
"retail district" and except on and next to the
street designated 50th Terrace in said City,
the cost of such construction to be paid for by
the issuance of the City's general obligation
bonds, and

WHEREAS, an engineer's preliminary
estimate in the amount of \$228,000 has been
prepared by the City's consulting engineers
and approved by the governing body of said
City, and

WHEREAS, all legal requirements per-
taining to the construction of certain side-
walk, curb and gutter replacement im-
provements have been complied with and the
work is now in progress, and

WHEREAS, there is now due the engineers
and contractors the sum of \$12,387.42 as
shown by approved invoices now on file and
said amount is now due and payable to such
engineers and contractors, and

WHEREAS, no funds are available to pay
said contractors and other expenses and said
City is authorized by K.S.A. 1973 Supp. 10-123
to issue temporary notes to pay the cost of
making an improvement which is to be paid
for by the issuance of bonds,

NOW, THEREFORE, BE IT ORDAINED
BY THE GOVERNING BODY OF THE CITY
OF WESTWOOD HILLS, KANSAS:

Section 1. That pursuant to the provisions
of K.S.A. 1973 Supp. 10-123, for the purpose of
paying the cost of the improvement herein-
before described, there shall be issued
Temporary Note No. 1, Series 1974, in the
principal amount of \$12,387.42. Said note shall
be dated June 1, 1974, shall mature June 1,
1975, or when called at the option of said City
by written notice to the holder thereof and
shall bear interest at the rate of four and
three-quarters per cent (4 3/4 percent) per
annum, payable at maturity, at the office of
the City Treasurer in the City of Westwood
Hills, Kansas.
