WHEREAS, the City of Westwood Hills, Kansas by resolution published in the official City newspaper on January 9, 1974 has authorized the construction of certain sidewalk, curb and gutter repair and replacement improvements throughout the City of Westwood Hills, Kansas except in that part of the City which has been officially designated "retail district" and except on and next to the street designated 50th Terrace in said City, the cost of such construction to be paid for by the issuance of the City's general obligation bonds, and

WHEREAS, an engineer's preliminary estimate in the amount of \$228,000 has been prepared by the City's consulting engineers and approved by the governing body of said City, and

WHEREAS, no funds are available to pay said contractors and other expenses and said City is authorized by K.S.A. 1973 Supp. 10-122 to issue temporary notes to pay the cost of making an improvement which is to be paid for by the issuance of bonds.
