

ORDINANCE NO. 91

AN ORDINANCE ESTABLISHING RATES OF SERVICE CHARGES TO BE PAID FOR THE USE OF THE SEWAGE DISPOSAL SYSTEM OF THE CITY OF WESTWOOD HILLS, KANSAS, PROVIDING FOR THE COLLECTION OF THE CHARGES FOR SAID SERVICE AND FOR THE DISPOSITION OF REVENUES DERIVED FROM SAID SEWER SERVICE CHARGES.

Be It Ordained By The Governing Body Of The City of Westwood Hills, Kansas:

Section 1. That the City of Westwood Hills deems it necessary and advisable to enact an ordinance to provide for the establishment of service charges to be paid for the use of the sewers of said city and the sewage disposal system of Kansas City, Missouri, all as provided and authorized by K.S.A. 12-631 (g) through (L), as amended.

Section 2. This ordinance and the charges hereinafter established shall apply to all persons, firms, corporations, city departments, the United States of America, The State of Kansas, and its political subdivisions, and any organization whose premises or improvements are connected or may hereafter be connected to the sanitary sewer system of the City of Westwood Hills.

Section 3. The following rates and service charges shall be made for the use of the sanitary sewer system of the City of Westwood Hills:

| (b) Commercial Establishments | \$3.50 per month |

Section 4. The charges herein prescribed shall be applicable to all houses and structures connected to the sanitary sewer system of the City of Westwood Hills, Kansas and shall apply irrespective of whether or not the house or structure is occupied or the water service to the house or structure is turned on.

Section 5. Collection of sewer service charges will be through county tax rolls. On or before August 15 of each year, the City Clerk will certify to the County Clerk of Johnson County the annual charge of \$42.00 for each applicable owner to be placed on the tax roll for collection, subject to the same penalties and collected in like manner as other taxes are by law collectable.

Section 6. The discharge of matter deleterious to the proper operation of the sewage treatment plant into the sewage system is hereby prohibited and any property upon which such prohibited discharge may hereafter occur shall be charged for the use of the sewage disposal system for each prohibited discharge the sum of \$100.00 as an additional service charge to be added to the regular monthly charge for such property.

Section 7. It shall be a misdemeanor for any person or persons to discharge matter deleterious to the proper operation of the sewage treatment plant into the sewage system, and any person convicted thereof shall be punished by a fine of not less than \$10.00 nor more than \$200.00.

Section 8. All revenues derived from sewer service charges shall be deposited in the treasury of the City of Westwood Hills and credited to a separate fund to be known as the Sewage Disposal Fund. The exclusive use of such funds shall be first for payments required by the City of Kansas City, Missouri for collection and treatment of sanitary sewage from the sanitary sewers of the City of Westwood Hills per cooperative agreement for sewer service between Kansas City, Missouri and Westwood Hills, Kansas effective January 1, 1975 and second for the administration, operation, maintenance, repair, replacement, extension, enlargement and improvement of the sanitary sewer system of the City of Westwood Hills.


Section 9. The sections of this ordinance are intended to be several and separate so that if any section is found to be invalid, the remaining sections shall be in full force and effect.

Section 10. This ordinance and the charges for sewer service as herein provided shall take effect upon publication and shall be published one time in the official city paper.

Section 2. This ordinance and the charges  
hereinafter established shall apply to all  
persons, firms, corporations, city depart-  
ments, the United States of America, The  
State of Kansas, and its political sub-  
divisions, and any organization whose  
premises or improvements are connected or  
may hereafter be connected to the sanitary  
sewer system of the City of Westwood Hills.

Section 3. The following rates and service  
charges shall be made for the use of the  
sanitary sewer system of the City of West-  
wood Hills:

(a) Residences \$3.50 per month

(b) Commercial Establishment \$15.00 per  
month

Section 4. The charges herein prescribed  
shall be applicable to all houses and struc-  
tures connected to the sanitary sewer system  
of the City of Westwood Hills, Kansas, and  
shall apply irrespective of whether or not the  
house or structure is occupied or the water  
service to the house or structure is turned on.

Section 5. Collection of sewer service  
charges will be through county tax rolls. On  
or before August 15 of each year, the City  
Clerk will certify to the County Clerk of  
Johnson County the annual charge of \$42 for  
each applicable owner to be placed on the tax  
roll for collection, subject to the same penal-  
ties and collected in like manner as other  
taxes are by law collectable.

Section 6. The discharge of matter deleter-  
ious to the proper operation of the sewage

treatment plant into the sewage system is  
hereby prohibited and any property upon  
which such prohibited discharge may  
hereafter occur shall be charged for the use

shall be punished by a fine of not less than

Section 8. All revenues derived from sewer  
service charges shall be deposited in the  
treasury of the City of Westwood Hills and  
credited to a separate fund to be known as the  
Sewage Disposal Fund. The exclusive use of  
such funds shall be for the payment of  
charges required by the City of Kansas City, Missouri  
for collection and treatment of sanitary  
sewage from the sanitary sewers of the City  
of Westwood Hills per cooperative agreement  
for sewer service between Kansas City,  
Missouri and Westwood Hills, Kansas ef-  
fective January 1, 1973 and second for the  
administration, operation, maintenance,  
repair, replacement, extension, enlargement  
and improvement of the sanitary sewer  
system of the City of Westwood Hills.

Section 9. The sections of this ordinance are  
intended to be several and separate so that if  
any section is found to be invalid, the  
remaining sections shall be in full force and  
effect.

Section 10. This ordinance and the charges  
for sewer service as herein provided shall  
take effect upon publication and shall be  
published one time in the official city paper.
