Vote by Mail

Due to increased interest in voting by mail caused by concerns about COVID-19, the Johnson County Election Office has now sent advance voting by mail applications to every active voter in the county. Voters should have received one application for each of the 2020 elections (primary and general). Voters who return the applications will receive ballots by mail to cast their votes at home.

If you wish to vote by mail, but did not receive an application to vote by mail, please contact the <u>Johnson County Election Office</u>. You may also wish to check your voter registration at <u>ksvotes.org</u> or at <u>jocoelection.org</u> (then go to Voter Look-up) to be certain you are an active voter. You can register to vote online on either website, and, once registered, request a vote by mail application.

Evergy COVID-19

In response to the coronavirus pandemic, Evergy announced in March that it will not disconnect electric service for non-payment of bills and will waive late fees for residential and small business customers. Evergy announced a flexible payment plan that allows customers, including those who have been disconnected, to enter a 12-month payment plan toward repaying their past-due balance. The suspension of disconnects is extended through July 15, 2020. Evergy will waive late fees and offer the payment arrangement through December 31,2020.

Margaret Rosberg - In Memoriam

2020 Cost Share Program

The City received a grant from the County to encourage residents to plant new trees and native plantings (on buffers/swales). We encourage residents to consider whether new native plantings would benefit their landscapes. Prior to any planting, the homeowner must submit an application to the City, describing the planting project. If a homeowner's application is approved, the City will reimburse half the cost of a native tree, up to \$150.00, half the cost up to \$1,000 on native plantings and buffers/swales and rain gardens, and half the cost up to \$1,000 for permeable pavement. All are limited to a maximum of one application per resident. However, homeowners may apply for an additional native tree after October 20, 2020, if funds remain. There is a limited amount of money, and first come, first served. **Projects requiring vegetation must be installed and completed by October 31, 2020 to promote establishment of the plantings. Native tree planting will be allowed until November 30, 2020.** Click here-for the application.

Construction and Other Vehicle Parking

Please ask your contractors and other visitors to park only on the authorized side of the street. If you see any illegal parking on your street, please ask the driver to move the vehicle, or call the non-emergency line for Westwood Police. Violators will be ticketed.
